### **Prevention of caste based discrimination in Higher Educational Institutions:**

According to the Constitution of India, Article 15: Prohibition of discrimination on Grounds of Religions, Race, Caste, Sex or Place of Birth:

- (1) The State shall not discriminate against any citizen on grounds only of religion, race, caste, sex, and place of birth or any of them.
- (2) No citizen shall on grounds only of religion, race, caste, sex, place of birth or any of them, be subjected to any disability, liability, restriction or condition with regard to-
  - (a) Access to shops, public, restaurants, hotels and places of public entertainment: or
  - (b) The use of wells, tanks, bathing ghats, roads and places of public resort maintained wholly or partly out of State funds or dedicated to the use of the general public.
- (3) Nothing in this article shall prevent the State from making any special provision for women and children.
- (4) Nothing in this article or in clause (2) of this article shall prevent the State from making any special provision for the advancement of any socially and educationally backward classes of citizens or for the Scheduled Castes and the Scheduled Tribes.

In terms of UGC's D.O.F. no.1-7/2011(SCT) dated 1<sup>st</sup> March, 2016, the following instructions are given.

No official/Faculty Member of this college shall indulge in any kind of discrimination against any community or category of students.

The Officials/Faculty Members should desist from act of discrimination against SC/ST students on grounds of their social origin.

A Complain Register is available in the office of the Principal (Ask PA to Principal)

If any such incident comes to notice of the Authorities, action shall be taken against the erring official/faculty members.
